NOTICE

Renewal of Admission of Continuing Students

In partial modification of the notice CU/AR/Orders & Notices/2017/052/ dated 12 November 2021 this is hereby notified that the ONLINE process for renewal admission will be open from **25th to 30th November, 2021.**

For the fee structure of each course the notice CU/REGOFF/2018/023/8052 dated 17 November 2021 may be referred to.

FEE WAIVER:

Students seeking fee waiver scheme will be able to fill up and upload **Valid Income Certificate** through the Google form (link: <https://forms.gle/RZxqCVvESxiwNK276>) till 24 November 2021. The documents listed vide Assam Govt. notification No. AHE.354/2021/11 dated 13 September will only be considered valid for the purpose of fee waiver. HS 1st marksheet is not required from HS 2nd year students. As per the Government of Assam instruction on Fee Waiver, students have to pay **Students' Welfare and Activity fee, Students' Union fee, and Magazine fee.**

Adjustment of Rs 3,000 paid by PG students during 1st Semester admission:

As notified at the time of 1st semester admission in 2020, the amount of Rs. 3,000 realised as refundable security deposit from students now in PG 3rd Semester (except self-financing programmes) will be adjusted with the fees payable for PG 3rd Semester.

- Assam domicile students *eligible for fee waiver this year* will be refunded the amount after deduction of the **Students' Welfare and Activity fee, Students' Union fee and Magazine fee for 2021-22.**
- Assam domicile students not eligible for fee waiver will pay the balance of the 3rd semester renewal admission fees after deduction or Rs. 3,000.00.
- The students with domicile outside Assam will have to pay the full fees for 1st semester admission plus 3rd semester renewal admission fees minus Rs 3,000.00.

Refund of CPGEE fees to Cotton Graduates:

Cotton Graduates admitted to PG 1st Semester in 2020 **who did not appear in CPGEE2020** and took admission on the basis of the CGPA scored in the qualifying examination will be refunded the amount of Rs 800 taken as CPGEE fees.

Self-financing Programmes:

Students of Self-financing UG and PG programmes (including outgoing UG 6th Semester and PG 4th Semester) have not yet paid even semester fees (January-June 2021). UG 3rd, 5th Semester and PG 3rd Semester students will pay the current fees together with the pending fees in two instalments. The first instalment will have to be paid within the dates mentioned above and the second instalment must be paid before the respective odd semester examinations. Payment link will also be opened to realise pending fees from outgoing UG 6th Semester and PG 4th Semester students of self-financing programmes.
