Cotton University Forum for the Specially Abled

Detailed Guidelines

Membership

The membership of the forum shall follow a three-tiered structure–

1. Membership by default, comprising all the specially abled students and staff of the University.
2. Voluntary membership having students and faculty members who may not be specially abled but empathise with the issues of the differently abled students.
3. Associate members which will include the alumni of the University who are specially abled.

For the initial phase, a body comprising of the following members will be formed by the Forum based on whose cooperation and discussion further course of actions will be undertaken.

1. Co-ordinator
2. One member from the Advisory Board
3. One member from the Executive Members
4. One member from the Voluntary Members
5. One member from the Associate Members

Proposed Plan of Action

1. Members will meet from time to time to assess and review the interests, issues and grievances of the specially abled students during an interval of every six months in a year and apprise the authorities about the actions taken so far to redress those concerns.
2. The forum will also look into any important developments in the sphere of technology which might aid the specially abled students in their learning process.
3. The forum will also observe the internationally acclaimed days attributed to the different categories of the specially abled including the United Nations' International Day of Persons with Disabilities, celebrated every year on 3rd of December.
4. Along with the voluntary members, the forum will organise various extra-curricular activities that might help in giving the specially abled students of the University a holistic and inclusive education.
5. To further execute the proposed Plan of Action, the co-ordinator will convene a meeting with the initial members, which includes individuals involved in the formulation of the forum, to discuss its organisational framework and other proposals.
6. The Forum will strictly adhere to academic activities and shall not get involved in any political activities.

Additionally, the aims and objectives, rules pertaining to membership and the proposed plan of action may evolve from time to time based on the requirements of the forum.
